Planning Commission: Mead reported that the PC met on April 17, 2023 – Commission discussed Master Plan and reviewed draft. Next meeting scheduled for May 15, 2023

NEW/OLD BUSINES:

Road Projects: Motion by Cooley to approve brining projects for Summer 2023 including Old US 31 totaling 18.56 miles. Support Mead. Roll Call: Mallon – yes; Mead – yes; Cooley – yes; Delorme – yes. Motion passed.

Cemetery: Cost Changes & Plot Request: Discussion held regarding plot purchases to non-residents and non-property owners. Clerk advised Board of the lack of available plots and future plots will require extensive adjustments to the property at Homestead Cemetery. Champion Hill lacks available land due to contour and valley within the cemetery. Clerk reminded Board that there is no perpetual care for cemeteries and all costs for maintenance and care comes from tax payer dollars. Thus, Non-residents and Non-property owner would never contribute to the maintenance and care of the cemeteries.

Clerk advised Board that significant effort has been made to accommodate the non-resident that is requesting to purchase plots, including family member sign off on rights to plots owned and not used by first blood relatives.

Mead states that Board needs to adhere to the Cemetery Ordinance.

No decision made regarding cost increases on cemetery plot purchases.

Park Restroom – Repairs and Camera: Vandals have damaged park restrooms windows. Discussion regarding surveillance cameras.

Upcoming Projects – Park and Building: Platte River Park Phase 4 is staged. Pit toilets, boat launch, pavilion and fishing piers.
